Yandal Resources Limited (ASX: YRL) (the "Company") confirms that it has issued and allotted a further 3,551,093 fully paid ordinary shares as detailed in the attached Appendix 2A as a portion of the shortfall placement.

On 12 June 2020, the Company announced the issue of approximately 13,369,595 fully paid ordinary shares at 25 cents per share through a rights issue to shareholders raising approximately \$3,342,399.

The majority of these shortfall shares have been placed with existing shareholders except for 610,000 which were placed with new investors.

The Company has issued the shortfall shares without disclosure to investors under section 708(1) of the Corporations Act 2001 (Cth) (Corporations Act).
